



## **EEZI AWN K9 Warranty :**

In the event that a product is defective, please contact the EEZI AWN K9 reseller you have purchased the EEZI AWN K9 product from.

All EEZI AWN K9 products must be returned to EEZI AWN or the reseller with a copy of the original invoice. Warranty approvals will not be granted if the original invoice or copy is not provided.

Subject to the limitations and exclusions described in the warranty. EEZI AWN will be given the right to remedy defects in materials or workmanship by repairing or replacing the item. In addition, EEZI AWN may elect as an option not to repair or replace the defective item or product but rather to issue the purchaser a refund or product to the value or equal to the purchase price paid for the product at our discretion. This can be used towards the purchase of a new EEZI AWN product.

As much as EEZI AWN K9 recreational vehicle equipment is manufactured with the finest materials to meet or exceed the highest standards in the industry. This warranty excludes problems caused by normal wear and tear, scratches, dents, tears or aesthetic oxidation of surfaces, natural break downs of colors and materials over extended use, damage due to storms, carelessness, wind, unlawful vehicle operation, and accidents.

No WARRANTY is given for defect resulting from conditions beyond EEZI AWN control including, but not limited to, modifications, damages caused by transportation or in correct stacking when stored, repairs or fitment not performed by an EEZI AWN authorized dealer, misuse, overloading, installation of the products or items in accordance with EEZI AWN K9 instructions made available to the original purchaser.

### **EEZI AWN K9 Roof racks, Load bars and Accessories (3 Years)**

EEZI AWN will warranty all K9 Roof racks, Load bars and Accessories for a period of 3 years from manufacture. The warranty will only stand if the roof rack is fitted to the vehicle using the correct k9 mounting system manufactured by EEZI AWN. The k9 Accessories warranty will only stand if fitted to an EEZI AWN K9 Rack system. This warranty terminates when the original retail purchaser sells or otherwise transfers the product to another person or entity.

### **EEZI AWN AWNINGS and Roof tents including hard shells (2Years)**

EEZI AWN will warranty all awnings, roof tents and hard-shell roof tents for a period of 2 years from manufacture. This warranty terminates when the original retail purchaser sells or otherwise transfers the product to another person or entity.

### **EEZI AWN K9 CHAIRS (2 Years)**

EEZI AWN will warranty the K9 Chair for a period of 2 years from manufacture. This warranty terminates when the original retail purchaser sells or otherwise transfers the product to another person or entity.

This warranty is expressly made in lieu of any and all other warranties. Including the warranties of merchantability and fit for a particular purpose.

EEZI AWN sole liability to and purchaser is limited to the remedy set forth above. In no event will EEZI AWN be liable for any lost profits, lost sales ,for any consequential ,direct ,indirect , incidental punitive damages or any other damages of any kind or nature.
